We have audited the accompanying Financial Statement – Form 4 of the Joe Swan Mayoral Campaign which includes the Statement of Campaign Income and Expenses for the period July 31 to December 31, 2014 related to the election held on October 27, 2014. The financial statement has been prepared by the Candidate based on the financial reporting provisions of the *Municipal Elections Act*, 1996.

### Candidates Responsibility for the Financial Statements

The Candidate is responsible for the preparation of this financial statement in accordance with the financial reporting provisions of the *Municipal Elections Act*, 1996, and for such internal control as the Candidate determines necessary to enable the preparation of the financial statement that is free from material misstatement, whether due to fraud or error.

### Auditors' Responsibility

Our responsibility is to express an opinion on this financial statement based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statement is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statement. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statement, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Campaign's preparation of the financial statement in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Campaign's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the Candidate, as well as evaluating the overall presentation of the financial statement.

We believe that the audit evidence we have obtained, including verifying Campaign contributions to the Campaign bank account statement, is sufficient and appropriate to provide a basis of our qualified audit opinion.

### Basis for Qualified Opinion

Due to the inherent nature of the transactions of organizations of this type, the completeness of the various categories of income and expenses is not susceptible to satisfactory audit verification. Accordingly, our verification of income and expenses was limited to the amount recorded in the Campaign's records and we were not able to determine whether any adjustments might be necessary to income and expenses and surplus/deficit.

### Qualified Opinion

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, this financial statement presents fairly, in all material respects, the income and expenses of the Joe Swan Mayoral Campaign from July 31 to December 31, 2014 in accordance with the financial reporting provisions of the *Municipal Elections Act*, 1996.

The Municipal Elections Act, 1996 does not require us to report, nor was it practicable for us to determine, that the contributions reported include only those which may be properly retained in accordance with the provisions of the Municipal Elections Act, 1996.
