**A** Approval not required if height does not exceed 4.11 m (13.5').

**B** Approval required only if a building is involved.

**C** Railway company approval required only when load exceeds 7.31 m (24') in width, 6.09 m (20') in height or 28.04 m (92') in length. Otherwise, Railway companies request 'Notification of Move' to be sent to them.

**D** This approval is always required, and:

- if the load is between 2.6 to 3.6 m in width and the height is less than 4.11 m and the length is less than 28.04 m (92'), then an annual permit can be issued for \$137.50.
- if the load is between 2.6 to 3.6 m in width and the height is less than 4.11 m and the length is less than 25 m, then a single occasion permit can be issued for \$27.50.
- if the load exceeds 3.65 m (12') in width and/or 4.11 m (13.5') in height and/or 25 m (82') in length, then a single occasion permit can be issued for \$71.50.

**E** These three clearances are the last ones to be obtained by the applicant in the order they appear. When all clearances have been obtained, the permit can be issued.

- Notes: 1. For confirmation that a demolition permit has been obtained at the old site  
2. For confirmation that a foundation permit has been obtained at the new site  
3. Winter weight restrictions are in effect December 1st to April 1st.
