

## SECTION 30

### AUTOMOBILE SERVICE STATION (SS) ZONE

#### 30.1 GENERAL PURPOSE OF THE SS ZONE

This Zone provides for and regulates a limited range of automotive related uses which provide a service to the immediate neighbourhood. The only use permitted in the main SS Zone variations gas bars which is the least intensive of the automotive uses. An expanded range of uses may be permitted in the other zone variation.

#### 30.2 PERMITTED USES

No person shall erect or use any building or structure, or use any land or cause or permit any building or structure to be erected or used, or cause or permit any land to be used, in any SS Zone or SS Zone variation for any use other than the following uses:

1) SS

The following are permitted uses in the SS Zone variation:

a) Gas bars.

2) SS1

The following are permitted uses in the SS1 Zone variation:

a) Automobile service stations;

3) Gas bars.

3) SS2

The following are permitted uses in the SS2 Zone variation:

a) Automotive uses, restricted.

4) SS3

The following are permitted uses in the SS3 Zone variation:

a) Any use permitted in the SS2 Zone variation;

b) Automobile repair garages.

5) SS4

The following are permitted uses in the SS4 Zone variation:

a) Any use permitted in the SS2 Zone variation;

b) Automobile sales and service establishments limited to six vehicles.

#### 30.3 REGULATIONS

No person shall erect or use any building or structure, or use any land or cause or permit any building or structure to be erected or used, or cause or permit any land to be used, in any SS Zone variation except in conformity with the regulations as set out in Table 30.3.

1) DRIVE-THROUGH FACILITIES

Drive-through facilities, either as a main or accessory use, are not permitted in the Automobile Service Station (SS) Zone.

The following zone variations apply to unique or existing situations and are not the standard SS Zone variations. If a regulation or use is not specified, the list of permitted uses and/or the regulations of Section 30.2 and/or Section 30.3 shall apply.
