### The City of London Tree Protection By-law C.P.-1555-252

#### Instructions to Applicant

1	<p>This is an application for a Permit to Destroy or Injure a Tree or Trees in a Tree Protection Area. You can use this application if the Tree(s) meets the following criteria:</p> <ul style="list-style-type: none"> <li>it is located within a <a href="#">Tree Protection Area</a> on Schedule B of this By-law</li> </ul> <p>This application is not to be used if the Tree is a Boundary Tree partially on the City's Boulevard. <a href="#">The Boulevard Tree Protection By-law -C.P.-22</a> would apply instead. Contact <a href="mailto:trees@london.ca">trees@london.ca</a></p> <p>If the Tree is a Boundary Tree, which is the property of all Landowners, all Landowners (or their authorized representative / agents) would need to make separate applications.</p>
2	<p>If an authorized representative / agent is applying for a Permit on behalf of the Landowner, the Landowner must complete the "Authorization of Landowner Representative / Agent" form, and it must be included with this Application.</p>
3	<p>The application <u>must</u> include an Arborist Report</p> <p><b>Application Deemed Incomplete</b> If the application does not contain everything required within 60 days of the receipt of the application by the City, or does not contain the information as further required within 60 days of the request, it shall be deemed to be incomplete and will not be processed.</p>
