#### Who we are:

In connection with the operation of its 10 arenas (22 ice pads), the City is responsible for the maintenance and property management of recreational ice facilities, the allocation of facility usage pursuant to joint use/joint venture agreements, the rental of ice time, the provision of public skating and other community access and coordination with community groups.

#### What we do:

The City provides a system of clean, safe, quality arenas and associated community centres that invite community organizations, sports organizations and residents to enjoy a variety of recreational activities. This contributes to the well-being of residents while promoting livable and inclusive neighbourhoods.

## Why we do it:

**Traditional** – The operation of arenas is a typical municipal function.
