

## SECTION 42 \*

### HEAVY INDUSTRIAL (HI) ZONE

#### 42.1 GENERAL PURPOSE OF THE HI ZONE

This Zone provides for and regulates industrial uses which are noxious and which should be separated from sensitive land uses. More general industrial uses will not be permitted in this Zone.

#### 42.2 PERMITTED USES

No person shall erect or use any building or structure, or use any land or cause or permit any building or structure or be erected or used, or cause or permit any land to be used, in any HI Zone variation for any use other than the following uses:

1) HI1

The following are permitted uses in the HI1 Zone variation:

- a) Armaments, munitions and explosive manufacturing industries;
- b) Manufacturing and assembly industries;
- c) Processed goods industries;
- d) Raw materials processing industries;
- e) Storage depots;
- f) Terminal centres;
- g) Transport terminals;
- h) Warehouse establishments;
- i) Waste treatment facilities;
- j) Residential and other source recycling facility;(Z.-1-031144)
- k) Specialized recycling facility;(Z.-1-031144)
- l) In-Vessel composting facility; and (Z.-1-031144)
- m) Channel composting facility; (Z.-1-031144)
- n) Impounding Yard; (Z.-1-223025)
- o) Tow Truck Business. (Z.-1-223025)

2) HI2

The following are permitted uses in the HI2 Zone variation:

- a) Automobile body shops;
- b) Automobile repair garages;
- c) Building or contracting establishments;
- d) Sale of vehicles reconditioned in association with 42.2(2)(a) and 42.2(2)(b);
- e) Impounding Yard; (Z.-1-223025)
- f) Tow Truck Business. (Z.-1-223025)

3) HI3

The following are permitted uses in the HI3 Zone variation:

- a) Any use permitted in the HI2 Zone variation;
- b) Impounding yards;
- c) Salvage yards;
- d) Tow Truck Business. (Z.-1-223025)

4) HI4

The following area permitted uses in the HI4 Zone variation:

- a) Construction and demolition recycling facility; (Z.-1-031144)
- b) Windrow composting facility. (Z.-1-031144)

#### 42.3 REGULATIONS

No person shall erect or use any building or structure, or use any land or cause or permit any building or structure to be erected or used, or cause or permit any land to be used, in any HI Zone variation except in conformity with the

regulations as set out below and in Table 42.3.

1) **GROSS FLOOR AREA (MAXIMUM)**

The maximum gross floor area for any individual use permitted in various HI Zone variations shall be as follows:

- a) Total gross floor area for retail sales accessory to a salvage yard: 1 000 m<sup>2</sup> (10,763.9 ft.)

2) **RECYCLING AND COMPOSTING FACILITIES**

A Certificate of Approval from the Ministry of the Environment must be obtained prior to the establishment of a recycling or composting facility, if required. (Z.-1-031144)

**42.4 SPECIAL PROVISIONS**

The following zone variations apply to unique or existing situations and are not the standard HI Zone variations. If a regulation or use is not specified, the list of permitted uses and/or the regulations of Section 42.2 and/or Section 42.3 shall apply.

**a) HI1 Zone Variation**

HI1(1) 16035 Robin's Hill Road

a) Additional Permitted Use

- i) Waste Transfer Station, subject to the following restrictions:
- a. Limited to transfer of medical and pharmaceutical waste;
  - b. Limited to the existing building;
  - c. Maximum Gross Floor Area of 600m<sup>2</sup>; and
  - d. Outdoor storage shall be prohibited. (Z.-1-202892)

**b) HI2 Zone Variation**

HI3(1)

a) Permitted Uses:

- i) Dwelling units ancillary to the main uses for persons required to live on the premises for security or maintenance purposes. (Z.-1-93174)

HI3(2)

a) Regulations:

- i) Lot Frontage (Minimum) 57 metres (187 feet) (Z.-1-97493)

HI3(3)

a) Permitted Use:

- i) Salvage yard with an associated auction establishment. (Z.-1-021003)

**d) HI4 Zone Variation**

a) Permitted Use:

i) Construction and demolition recycling facility.
