

Community Housing Internal Reviews Information and Application

Information for community housing applicants and tenants/members regarding **internal review** of certain decisions.

What decisions can be reviewed?

Internal reviews are specific to community housing/rent-geared-to-income issues governed under the Housing Services Act, 2011 and related local rules.

It is important to note that this **DOES NOT INCLUDE** matters that fall under the Residential Tenancies Act, 2006 or issues related to co-operative housing.

When and how do I request an internal review?

To request an internal review, you must already have received a written **Notice of Decision** from either the Housing Access Centre or your community housing provider regarding a matter governed under social housing rules.

Depending on who provided you with your Notice of Decision, either the Housing Access Centre or your community housing provider, internal reviews are submitted directly to them.

Please complete the **Request for Internal Review** attached below and include a copy of your **Notice** of **Decision**.

Requests must also include:

- Your full name
- Current address
- Signature
- The reason you are requesting an internal review
- Any supportive documents or information you feel supports your request

Important Notice

A decision on your Internal Review will be sent to you within 15 business days of receiving your request.
