

Application Details

Requested Zoning By-law Amendment

To change the zoning from a Residential R5-5/R6-5/R7 *D100 *H30 Zone to Residential R5-5/R6-5/R7(_) *D100 *H30 Zone. Changes to the currently permitted land uses and development regulations are summarized below.

The Zoning By-law is available at london.ca.

Current Zoning

Zone: R5-5/R6-5/R7 *D100 *H30

Permitted Uses: R5: Cluster townhouse dwellings, Cluster stacked townhouse dwellings, R6: Single detached dwelling, Semi-detached dwelling, Duplex dwelling, Triplex dwelling, Townhouse dwelling, Stacked Townhouse dwelling, Apartment buildings, Fourplex dwelling, R7: Senior citizen apartment buildings, Handicapped persons apartment buildings, Nursing homes, Retirement lodges, Continuum-of-care facilities, and Emergency care establishments.

Special Provision(s): None

Residential Density: 100 units per hectare

Height: 30.0m Bonus Zone: None

Requested Zoning

Zone: R5-5/R6-5/R7(_) *D100 *H30

Permitted Uses: Same as above, adding School to the R7 uses. **Special Provision(s):** R7(_): maximum gross floor area (GFA) of 600m².

Residential Density: No changes requested.

Height: No changes requested.

Planning Policies

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document. The subject lands are in the Neighbourhoods Place Type in The London Plan, permitting residential uses, as well as a limited range of neighbourhood-related retail, institutional and office uses.

How Can You Participate in the Planning Process?

You have received this Notice because someone has applied to change the zoning of land located within 120 metres of a property you own, or your landlord has posted the notice of application in your building. The City reviews and makes decisions on such planning applications in accordance with the requirements of the Planning Act. Reply to this Notice of Application

We are inviting your comments on the requested changes at this time so that we can consider them as we review the application and prepare a report that will include Planning & Development staff's recommendation to the City's Planning and Environment Committee. Planning considerations usually include such matters as land use, development intensity, and form of development.

Attend This Public Participation Meeting

The Planning and Environment Committee will consider the requested Official Plan and zoning changes at this meeting, which is required by the Planning Act. You will be invited to provide your comments at this public participation meeting. A neighbourhood or community association may exist in your area. If it reflects your views on this application, you may wish to select a representative of the association to speak on your behalf at the public participation meeting. Neighbourhood Associations are listed on the Neighbourgood website. The Planning and Environment Committee will make a recommendation to Council, which will make its decision at a future Council meeting.

What Are Your Legal Rights?

Notification of Council Decision

If you wish to be notified of the decision of the City of London on the proposed zoning by-law amendment, you must make a written request to the City Clerk, 300 Dufferin Ave., P.O. Box 5035, London, ON, N6A 4L9, or at docservices@london.ca. You will also be notified if you speak to the Planning and Environment Committee at the public meeting about this application and leave your name and address with the Clerk of the Committee.

Right to Appeal to the Ontario Land Tribunal

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the City of London to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.


Notice of Collection of Personal Information


Site Concept
