Requested Zoning By-law Amendment

Possible change to Zoning By-law Z.-1 from Residential R6 Special Provision (R6-5(80)) and Neighbourhood Shopping Area Special Provision (NSA3(3)) Zones to Residential R6 Special Provision (R6-5(_)) and Neighbourhood Shopping Area Special Provision (NSA3(_)) Zones. Changes to the currently permitted land uses and development regulations are summarized below.

Current Zoning

Zone: R6-8(80)

Permitted Uses: Single detached dwelling; Semi-detached dwelling; Duplex dwelling; Triplex dwelling; Townhouse dwelling; Stacked Townhouse dwelling; Apartment buildings Fourplex dwelling.

Special Provisions: Minimum front yard setback: 4.5m. Maximum Density: 70 units per hectare.

Height: 12 metres

Zone: NSA3(3)

Permitted Uses: Bake shops; Catalogue stores; Clinics; Convenience service establishments; Day care centres; Duplicating shops; Financial institutions; Food stores; Libraries; Medical/dental offices; Offices; Personal service establishments; Restaurants; Retail stores; Service and repair establishments; Studios; Video rental establishments; Brewing on Premises Establishment; An apartment building with any or all of the other permitted uses on the first and/or second floor.

Special Provisions: Minimum lot depth: 36.0 metres, Minimum front yard depth: 1.0 metres, Maximum front yard depth: 3.0m, Minimum interior side yard setback (south): 11.0 metres, Maximum height: 11.0 metres, Minimum parking spaces: 48, Maximum density: 85 units per hectare.

Height: 11 metres

Requested Zoning

Zone: R6-8(80) and NSA3(3) **Permitted Uses:** Same as above, plus Place of Worship **Special Provisions:** Permitted use: Place of Worship. **Height:** No proposed change

The City may also consider the use of holding provisions, and additional special provisions to facilitate the proposed development.

Planning Policies

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document. These lands are currently designated as Shopping Area Place Type in The London Plan.

The subject lands are in the Shopping Area Place Type in The London Plan. Uses contemplated include a range of commercial, service, office, entertainment, recreational, educational, institutional and residential uses..

How Can You Participate in the Planning Process?

You have received this Notice because someone has applied to change the Official Plan designation and the zoning of land located within 120 metres of a property you own, or your landlord has posted the notice of application in your building. The City reviews and makes decisions on such planning applications in accordance with the requirements of the Planning Act. Attend This Public Participation Meeting

The Planning and Environment Committee will consider the requested Official Plan and zoning changes at this meeting, which is required by the Planning Act. You will be invited to provide your comments at this public participation meeting. A neighbourhood or community association may exist in your area. If it reflects your views on this application, you may wish to select a representative of the association to speak on your behalf at the public participation meeting. Neighbourhood Associations are listed on the <u>Neighbourgood</u> website. The Planning and Environment Committee will make a recommendation to Council, which will make its decision at a future Council meeting.

What Are Your Legal Rights?

Notification of Council Decision

If you wish to be notified of the decision of the City of London on the proposed official plan amendment and/or zoning by-law amendment, you must make a written request to the City Clerk, 300 Dufferin Ave., P.O. Box 5035, London, ON, N6A 4L9, or at <u>docservices@london.ca</u>. You will also be notified if you speak to the Planning and Environment Committee at the public meeting about this application and leave your name and address with the Clerk of the Committee.

Right to Appeal to the Ontario Land Tribunal

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the City of London to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the proposed official plan amendment is adopted, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the proposed official plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the City of London to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
