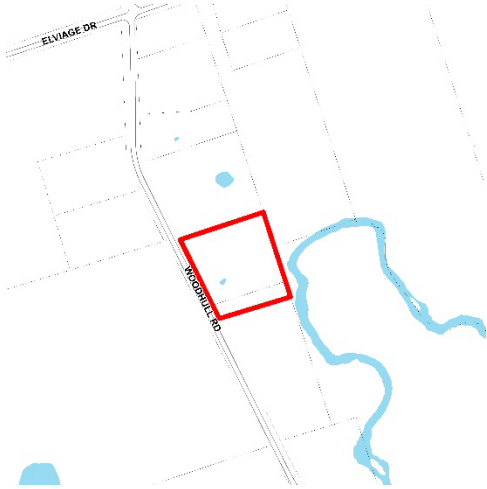

What is Proposed?

Zoning amendment to allow:

- A single detached dwelling.
- Special provisions requested for lot frontage; lot area; minimum yard setbacks; maximum lot coverage; and to permit the proposed use.

Application Details

Requested Zoning By-law Amendment

Possible change to Zoning By-law Z.-1 FROM a holding Agricultural and Open Space (h-4*AG2/h-2*OS4) Zone TO an Agricultural Special Provision and Open Space (AG2(_)/OS4) Zone. Changes to the currently permitted land uses and development regulations are summarized below.

Current Zoning

Zone: holding Agricultural and Open Space (h-4*AG2/h-2*OS4) Zone

AG2 Permitted Uses: Agricultural uses; Livestock facilities provided that such facilities are located at least 300 metres from the City's Urban Growth boundary; or in accordance with the MDS regulations, whichever is greater; Farm dwelling; Forestry uses; Kennels; Conservation lands; Wayside pits; Nursery; Passive recreation use; Farm market; Small Wind Energy Conversion System; Greenhouse Farm; Livestock facilities; Compost facility; Aquaculture; Agricultural research station; Manure storage facility; and Mushroom Farm.

OS4 Permitted Uses: Conservation lands; Conservation works; Golf courses without structures; Private parks without structures; Public parks without structures; Recreational golf courses without structures; Cultivation or use of land for agricultural/horticultural purposes; and Sports fields without structures.

Requested Zoning

Zone: Agricultural Special Provision and Open Space (AG2(_)/OS4) Zone

Permitted Uses: Same as above.

Special Provisions (2624 Woodhull Road): Reduced lot frontage of 38.0 metres whereas 300 metres is the minimum required; reduced lot area of 0.18 hectares whereas 30 hectares is the minimum required; reduced minimum front yard setback of 14.0 metres whereas 30.0 metres is required; reduced minimum interior side yard setbacks of 3.0 metres whereas 30.0 metres is required; reduced minimum rear yard setback of 10.0 metres whereas 30.0 metres is required; increased maximum lot coverage of 24% whereas 10% is the maximum permitted; and to permit single detached dwellings as an additional permitted use.

Special Provisions (2598 Woodhull Road): Reduced lot area of 0.34 hectares whereas 30 hectares is the minimum required.

The City may also consider the use of holding provisions, and additional special provisions to facilitate the proposed development.

Planning Policies

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document.

The subject lands are in the Farmland and Green Space Place Types, fronting on a Rural Connector, Woodhull Road, in The London Plan. Uses permitted include but are not limited to agricultural uses; residential uses on existing lots of record; home occupation; and secondary farm occupation and on-farm diversified uses.

How Can You Participate in the Planning Process?

You have received this Notice because someone has applied to change the Official Plan designation and the zoning of land located within 120 metres of a property you own, or your landlord has posted the notice of application in your building. The City reviews and makes decisions on such planning applications in accordance with the requirements of the Planning Act. The ways you can participate in the City's planning review and decision-making process are summarized below.

We are inviting your comments on the requested changes at this time so that we can consider them as we review the application and prepare a report that will include Planning & Development staff's recommendation to the City's Planning and Environment Committee. Planning considerations usually include such matters as land use, development intensity, and form of development.

Attend This Public Participation Meeting

The Planning and Environment Committee will consider the requested Official Plan and zoning changes at this meeting, which is required by the Planning Act. You will be invited to provide your comments at this public participation meeting. A neighbourhood or community association may exist in your area. If it reflects your views on this application, you may wish to select a representative of the association to speak on your behalf at the public participation meeting. Neighbourhood Associations are listed on the [Neighbourgood](#) website. The Planning and Environment Committee will make a recommendation to Council, which will make its decision at a future Council meeting.

What Are Your Legal Rights?

Notification of Council Decision

If you wish to be notified of the decision of the City of London on the proposed official plan amendment and/or zoning by-law amendment, you must make a written request to the City Clerk, 300 Dufferin Ave., P.O. Box 5035, London, ON, N6A 4L9, or at docservices@london.ca. You will also be notified if you speak to the Planning and Environment Committee at the public meeting about this application and leave your name and address with the Clerk of the Committee.

Right to Appeal to the Ontario Land Tribunal

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the City of London to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the proposed official plan amendment is adopted, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the proposed official plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the City of London to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
