

What is Proposed?

Draft Plan of Vacant Land Condominium to allow:

- 26 semi-detached dwelling units;
- 3 townhouse dwelling units;
- Individual driveways for 12 of the semi-detached dwellings units from Eagletrace Drive.
- One new private road and sidewalks providing access from Eagletrace Drive to all other dwelling units; and
- Shared common elements including visitor parking and landscaped open space.

Application Details

Requested Draft Plan of Vacant Land Condominium

Consideration of a Draft Plan of Vacant Land Condominium with a total of 29 dwelling units, comprised of 26 semi-detached dwelling units and 3 townhouse dwelling units. Vehicle access from Eagletrace Drive is proposed to be provided via private driveways for 12 of the semi-detached dwellings, and a new private road for all other dwelling units. A common element for visitor parking and landscaped open space is included. This property is currently the subject of an application for Site Plan Approval SPA23-082. No amendments to the Official Plan or Zoning By-Law are being requested.

Planning Policies

These subject lands are currently designated Neighbourhoods Place Type with frontage on a Neighbourhood Connector (Eagletrace Drive) in the London Plan, permitting a range of residential dwelling types including single detached, semi-detached, duplex, triplex, and townhouse, as well as small-scale community facilities. The subject lands are currently zoned Residential h*R5-2/R6-4 which permits cluster developments comprised of single detached, semi-detached, duplex, townhouse and stacked townhouse dwellings.

How Can You Participate in the Planning Process?

You have received this Notice because someone has applied for a Draft Plan of Vacant Land Condominium on land located within 120 metres of a property you own, or your landlord has posted the notice of application in your building. The City reviews and makes decisions on such planning applications in accordance with the requirements of the *Planning Act*. 
Notice of Collection of Personal Information
