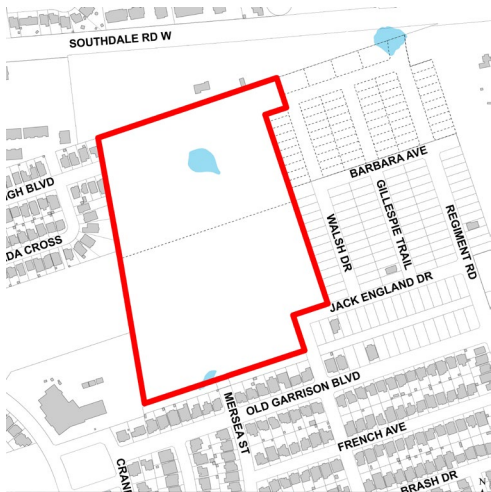

#### What is Proposed?

An Official Plan Amendment is proposed to remove the Green Space Place Type on Map 1 of The London Plan and the Open Space and Environmental Review designation on Schedules 4 and 12 of the Southwest Area Secondary Plan (SWAP) associated with the wetlands on the northern part of the subject lands.

The open space block, which includes the significant woodland and the proposed ecological compensation area, is proposed to be added to the Green Space Place Type in The London Plan and the Open Space and Environmental Review designation in the SWAP.

# Application Details

## Requested Official Plan Amendment

Consideration of an Official Plan Amendment is proposed to remove the Green Space Place Type on Map 1 of The London Plan and the Open Space and Environmental Review designation on Schedules 4 and 12 of the Southwest Area Secondary Plan (SWAP) associated with the wetlands on the northern part of the subject lands. In the SWAP, the boundary between the Low Density Residential Designation and the Medium Density Residential Designation is interpreted to be Raleigh Boulevard and the Official Plan Amendment will update the designations to reflect the proposed road network.

The Official Plan Amendment is also proposed to redesignate the significant woodland and ecological compensation areas. Consistent with the proposed compensation plan the open space block, which includes the significant woodland, is proposed to be added to the Green Space Place Type in The London Plan and the Open Space and Environmental Review designation in the SWAP to ensure the long term protection of these areas.

This Official Plan Amendment will be considered in conjunction with the Zoning By-Law Amendment (Z-9791) and Draft Plan of Subdivision (39T-24504) also under review for these lands. The OPA will facilitate the development of a residential subdivision with 133 single detached dwellings and townhouse dwellings, and the protection of significant natural heritage features.

## Planning Policies

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document. The subject lands are in the Neighbourhoods Place Type in The London Plan, permitting a range of low to medium density residential uses as well as mixed-use and commercial uses at appropriate locations to meet the daily needs of neighbourhood residents.

## How Can You Participate in the Planning Process?

You have received this Notice because someone has applied to change the zoning of land located within 120 metres of a property you own, or your landlord has posted the notice of application in your building. The City reviews and makes decisions on such planning applications in accordance with the requirements of the Planning Act. The ways you can participate in the City's planning review and decision-making process are summarized below.

### Reply to this Notice of Application

We are inviting your comments on the requested changes at this time so that we can consider them as we review the application and prepare a report that will include Planning & Development staff's recommendation to the City's Planning and Environment Committee. Planning considerations usually include such matters as land use, development intensity, and form of development.

### Attend This Public Participation Meeting

The Planning and Environment Committee will consider the requested official plan and zoning changes at this meeting, which is required by the Planning Act. You will be invited to provide your comments at this public participation meeting. A neighbourhood or community association may exist in your area. If it reflects your views on this application, you may wish to select a representative of the association to speak on your behalf at the public participation meeting. Neighbourhood Associations are listed on the [Neighbourgood](http://Neighbourgood) website. The Planning and Environment Committee will make a recommendation to Council, which will make its decision at a future Council meeting.

# What Are Your Legal Rights?

## Notification of Council Decision

If you wish to be notified of the decision of the City of London on the zoning by-law amendment, you must make a written request to the City Clerk, 300 Dufferin Ave., P.O. Box 5035, London, ON, N6A 4L9, or at [docservices@london.ca](mailto:docservices@london.ca). You will also be notified if you speak to the Planning and Environment Committee at the public meeting about this application and leave your name and address with the Clerk of the Committee.

## Right to Appeal to the Ontario Land Tribunal

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the City of London to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the proposed official plan amendment is adopted, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the proposed official plan (or official plan amendment) is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Corporation of the City of London to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of London before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

If a person or public body would otherwise have the ability to appeal the decision of the Council of the Corporation of the City of London but does not make oral submissions at a public meeting, if one is held, or make written submissions to the City of London in respect of the proposed plan of subdivision before the approval authority gives or refuses to give approval to the draft plan of subdivision, the person or public body is not entitled to appeal the decision to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at a public meeting, if one is held, or make written submissions to the City of London in respect of the proposed plan of subdivision before the approval authority gives or refuses to give approval to the draft plan of subdivision, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

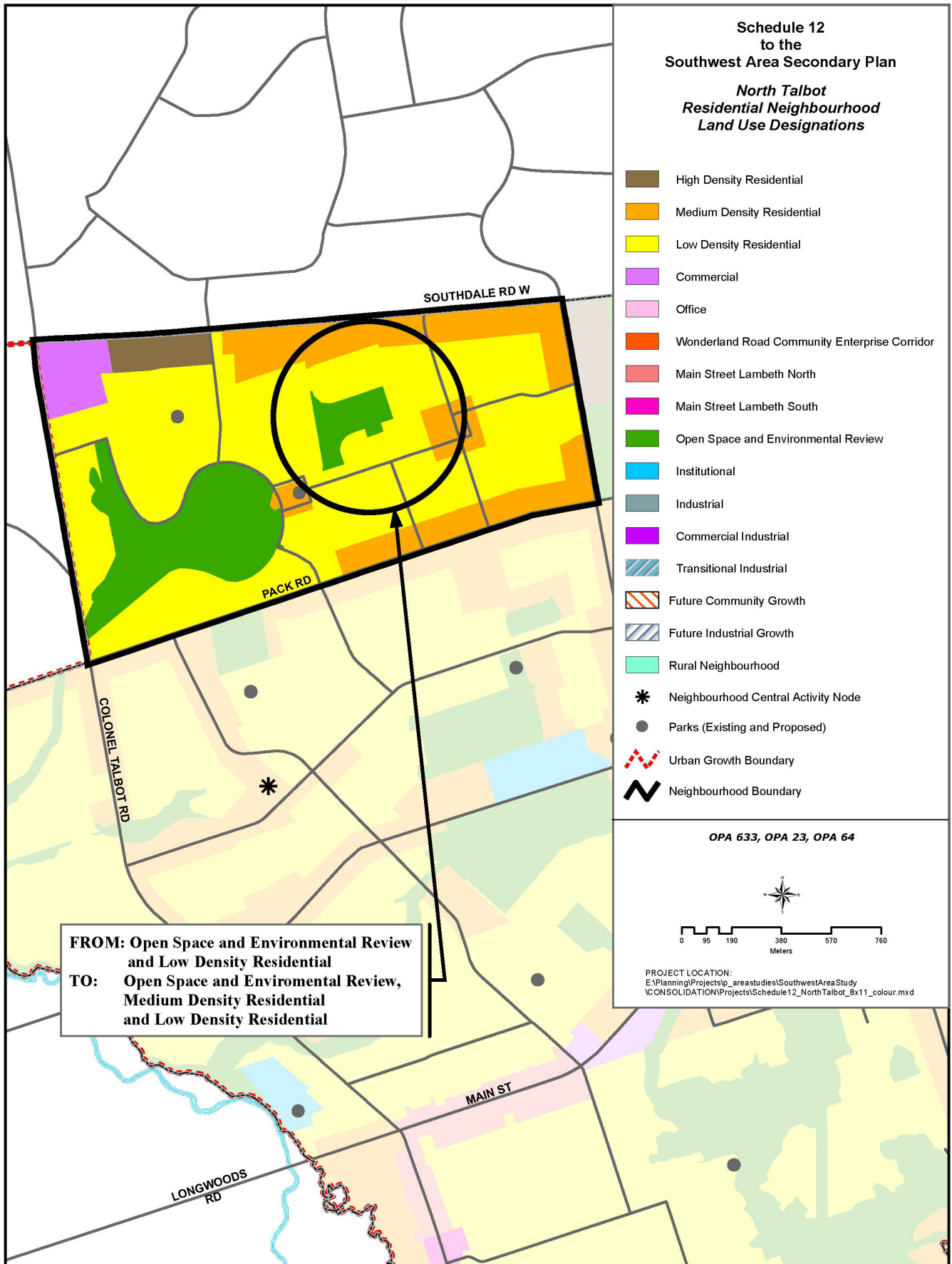


Figure 1. Proposed Amendment to Schedule 4 of the SWAP
